- (b) The Isles Wind Farm comprising 24 turbines (7 with a maximum tip height of up to 126.5m on land to the north west of the A1(M) and north of Great Isle Farm, 13 with a maximum tip height of up to 101m and 4 with a maximum tip height of up to 115m on land between Mordon and Prestonle-Skerne), 1 permanent 80m high anemometer mast, and associated infrastructure including control building and substation compound, access roads and related engineering works on land near Mordon, Bradbury and Preston-le-Skerne.
- (c) Proposed single storey side extension to replace existing conservatory at 5 St. Andrews Close, Aycliffe Village.

(2) The Council received <u>for information</u> Prior Notification Planning Applications – (for information only)

- (a) Prior Notification of proposed demolition of existing rail bridge at Railway Bridge DAE1/12 to the South of Millennium Way, Aycliffe Business Park.
- (b) Prior Notification for the erection of a conservatory to the rear measuring 3.6 meters in length, 3.3 metres in width and 3 metres in height to the apex of the roof at 15 Bewick Crescent, Newton Aycliffe.
- (3) The Council received <u>for information</u> the undermentioned planning applications, prior notice of which has been circulated to all Members of the Council. Durham County Council have been notified of the listed comments on each application:-
- (a) Erection of external inglenook fireplace to the side and replacement windows at 12 High Barn Road, School Aycliffe. *No objections.*
- (b) Variation of condition 2 of planning permission 7/2013/0087/DM to alter turning head and substation at Former Tetley Tea Distribution Centre, Grindon Way, Aycliffe Business Park.

- (c) Erection to existing car park to provide overspill at The Work Place, Heighington Lane, Aycliffe Business Park. No objections.
- (d) Erection of single storey rear extension 17 Bloomsley Close. *No objections.*
- (e) Variation of planning permission to infill windows to the retained clock tower Churchill House, Beveridge Way, Newton Aycliffe. *No objections*.

RESOLVED - that it be recommended:-

- (i) Applications 1 (a) and (c) no objections.
- (ii) Application 1 (b) Windfarms that an objection be made under the following planning regulations:-

- a) The Sedgefield Borough Council saved local plan policies does not allow such a development.
- b) The Durham County Plan, soon to be approved, does not allow such a development.
- c) The windfarm would have an unacceptable and detrimental visual impact on the character and appearance of the surrounding area.
- d) The windfarm would have a very unacceptable landscape/environmental impact on the delicate area of the Carrs and surrounding land.
- e) The windfarm would compromise housing development proposed for Copelaw by the Durham County Plan.
- f) The cumulative impact of this development, added to all the other windfarms in the area, would be excessive.
- g) The Town Council would object to what will amount to an industrialisation of a rural landscape so close to a major town.
- (iii) Applications 2 (a) and (b) that the information be received.
- (iv) Applications 3 (a) to (e) that the information be received.
