INTRODUCTION

The following Constitution has been agreed by Great Aycliffe Town Council. It contains information about how the Council operates, how decisions are made and the procedures which are followed to ensure that those decisions are efficient, transparent and accountable to the community.

The Constitution is divided into 14 articles which set out the basic rules for governing the Council's business.

PURPOSE OF THE CONSTITUTION

The purpose of the Constitution is to bring together a number of documents to:

1. Enable decisions to be taken efficiently and effectively;
2. Enable the Council to be a clear, transparent and accountable organisation;
3. Create an effective means of holding decision-makers to public account;
4. Ensure that those responsible for decision making are clearly identifiable;
5. Encourage the active involvement of citizens in the Town Council's decision making;

MISSION STATEMENT

All of the elements of the Constitution aim to assist the Town Council in achieving its mission to be:-

"A proactive and responsive Council, working in partnership, listening to and speaking up for the community, contributing towards making Great Aycliffe an excellent place in which to live for all its residents".

COUNCIL STRATEGIC AIMS

The Council has agreed eight strategic aims in support of its mission statement. These are:

1. *To provide good quality governance and management of the Council.*
2. *To manage the council's finances and assets in a responsible manner.*
3. *To provide accessible, affordable leisure facilities and opportunities.*
4. *To provide pre-school education as appropriate in Great Aycliffe.*
5. *To contribute to the environmental improvement of Aycliffe by managing and developing parks, play areas and green spaces.*
6. *To help and encourage partnership working to improve the services and facilities for the residents of Great Aycliffe.*
7. *To encourage the residents of Great Aycliffe to become involved in local democracy.*
8. *To research information and make the case for Great Aycliffe.*

COUNCIL SERVICES

Great Aycliffe Town Council provides a wide variety of services to the local community and these services are set out below:

- Oakleaf Sports Complex which provides indoor bowls, multi-use sports hall, squash courts, bar and catering service, function room, children's holidays activities and indoor and outdoor sports coaching.
- Oakleaf Golf Complex offering an 18-hole golf course, 16 bay floodlit driving range, changing rooms and golf shop.
- Manage Stephenson Way Cemetery and West Cemetery and provide a burial service at these cemeteries. Also provide grounds maintenance and burial services at St Andrew's Churchyard in Aycliffe Village.
- Manage the following nine parks, all with play equipment:

- Provide four additional play areas at Scott Place, School Aycliffe, Oak Leaf Complex and Horndale.
- Provide six football pitches and mini-soccer pitches.
- Run two pre-school play settings at St Oswald's Park both with an 'outstanding' Ofsted rating.
- Provide and manage a wide range of community events including Fun-in-the-Parks, Santa Tours, Firework Display, Senior Citizen Trips, Christmas Lights.
- Assist and support other organisers to provide events including the 10km race, 3km fun run, Remembrance Day Parade, Big Brass Bash, Aycliffe Music Festival, Junior Cross Country, Annual Indoor Bowls Competition, golf competitions and the Community Enhancement Awards (floral displays and festive lights).
- A range of civic events including the civic ball and mayor at home.
- Provision and maintenance of Aycliffe Angels Memorial Garden,
- Maintenance of the war memorial and flagpole.
- Five allotment sites with pigeon, poultry and apiary facilities.
- Provide an environmental centre at Moore Lane and a programme of environmental activities and voluntary work programmes.
- Comment on all planning applications, with particular reference to the Great Aycliffe Neighbourhood Plan.
- Public seats in many locations
- Bus shelters with litter bins (not the shelters with adverts)
- Grounds maintenance and environmental management in the following areas:-

Woodham Burn	Simpasture Railway Walk
Great Aycliffe Way	Millfields / Bickford Terrace
Butterfly Meadow at Rail Halt	School Aycliffe Wetlands
- Aycliffe Village Greens – legal custodians and maintenance.
- Crime prevention - the Council provides park wardens and CCTV cameras.
- Community Empowerment and Engagement via community consultation surveys, events and open days.
- Grants and Donations – small grants and donations to local community and voluntary organisations.
