1.0 Purpose of the Report

1.0 The purpose of the report is to ask Members to consider the replacement of the boundary fence of Aycliffe Village Allotments.

2.0 Background Information

- 2.1 The existing wooden fence is in a poor condition, with rotten posts and leaning panels currently being propped up by additional wooden supports or simply trees and bushes.
- 2.2 A map showing the area of the proposed fencing replacement can be seen in Appendix 1.
- 2.3 A budget sum of £10,000 has been allocated in the 2024/25 Capital Programme Budget for replacement gates and fencing at Aycliffe Village Allotments.
- 2.4 This project has been identified by the Council as an essential project in the 2024/25 Capital Programme Budget.

3.0 Current Situation

- 3.1 It is proposed that the fencing be replaced at 1.2 metres high, rather than the 2 metres high palisade fencing installed at the Council's other allotment sites.
- 3.2 The location of the site and the reduced need for security mean that the fencing will be more in keeping with the village setting.
- 3.3 Quotations were sought from Rennyco Security Fencing, Peart Fencing and Deerness Fencing & Landscapes for two different options: -

- 3.4 Both Rennyco and Deerness Fencing and Landscapes attended the site to carry out an initial site survey prior to supplying quotations.
- 3.5 Peart Fencing have not attended the site and initially supplied a quotation for supply only. Upon repeated requests, an updated estimate for 'supply and installation' was given, but it should be noted that "rates are obviously based on site survey / inspection prior to order being placed."

4.0 Policy Implications

- 4.1 This report complies with the following Council Strategic Aims: -
 - Aim No. 2. To manage the Council's finances and assets in a responsible manner
 - Aim No. 5. To contribute to the environmental improvement of Aycliffe by managing and developing parks, play areas and green spaces.

5.0 Staffing Implications

5.1 Works Section staff would be employed to remove the existing wooden fence and cut back any vegetation to allow installation of the new fencing. This has helped to keep the quoted cost of installation down.

6.0 Financial Implications

- 6.1 A budget sum of £10,000 has been allocated in the 2024/25 Capital Programme Budget for replacement of Aycliffe Village Allotment fencing.
- 6.2 The estimates received to replace the boundary fence are summarised below:-

6.3 It has been advised that due to the current instability in the price of materials, the estimates received may be subject to change at short notice.

- 6.4 The officer's preferred option would be roll top mesh and it is recommended that the lowest quote, from Deerness Fencing, at £9,846.96, is agreed.

- 9.1 All suppliers contacted are within 22 miles of Newton Aycliffe. Rennyco Security Fencing being the closest at approximately 6 miles away.

- 12.1 It is recommended that Members:

 - iv) Note that if palisade fencing is the preferred option, an additional capital budget approval of £2,433 would need to be agreed.
